School Access Route Plan

Wilson Elementary School

In accordance with state standards, Wilson Elementary School has identified school access routes for Wilson School students who <u>live within the walk boundary established for the school</u>. The intent of a School Access Route Plan is <u>not</u> to identify every school access route or to identify the more convenient school access routes; it is to identify main walk/bike routes that appear to be secure. Care has been taken to consult with local law enforcement, school PTA and School Community Council representatives, and the District's traffic safety committee in establishing these school access routes. Despite broad consultation and unanimous agreement from all parties involved in establishing these routes, no one, including the Nebo School District and Wilson School can guarantee that the agreed upon school access routes are or will ever be completely free from hazards.

Parents are encouraged to walk or bike the school access routes with their child/children, to address specific concerns they may have, and to instruct their child/children to obey the laws and rules pertaining to pedestrian safety. If a parent feels their child/children should use a school access route that <u>is not</u> identified in this plan, it is their prerogative to instruct their child/children as to what they feel is best for them.

As previously stated, the intent of a School Access Route Plan is <u>not</u> to identify every school access route or to identity the more convenient school access routes. For this plan, school access routes leading to the school from areas where clusters of students live, have been identified and are described below.

School Access Route Descriptions:

Wilson Elementary School Walking Access Route

Zone #1: Students who live between 500 South and 800 South and between 500 and 400 West, should funnel East to 400 West. At 400 West they should travel North on the West side of the road to 500 South. At the intersection of 500 South and 400 West students should travel west to the intersection of 500 South and 500 west. At that point, they should cross with the Crossing Guard and continue going west until they reach the school.

Students living between 500 South and 800 South and East of 400 West, should funnel to 400 West and walk on the East side of the road North to 500 South. At the intersection of 400 West and 400 South they should travel West to the intersection of 500 South and 500 West. At that point, they should cross with the Crossing Guard and continue going West until they reach the school.

Zone #2: Students who live between 500 South and 800 South and between 600 and 700 West should funnel to 600 West and then travel North on 600 West on the West side of the road until they reach 500 South and cross with the Crossing Guard until they reach the school.

Zone #3: Students who live between 500 South and 800 South and between 700 West and 800 West should funnel to 700 West and travel North on the East side of the road to 500 South. At 500 South they should travel East on the North side of the road until they reach the Crossing Guard at the intersection of 500 South and 600 West and then they will cross the road until they reach the school.

Students who live West of 800 West and between 500 and 700 South should funnel East to 800 West. At 800 West, they should travel North on the West side of the road to 500 South and at that point they should cross with the crossing guard. They will then go East to 600 West on the North side of the road. When they reach the intersection of 500 South and 600 West they will cross the road with the Crossing Guard until they reach the school.

Zone #4: Students who live South of 450 South and West of 1000 West should make their way to the 450 South, 1000 West intersection. At this intersection cross to the East side of 1000 West using the South side of the intersection. The students will then travel East on the South side of 450 South until they reach 800 West. At 500 South and 800 West, they should cross the road with the Crossing Guard traveling East on the North side of the road until they reach the intersection of 600 West and 500 South. At this point they will cross with the Crossing Guard until they reach the school.

Students who live between 300 South and I-15, 450 South and along 900 West should funnel South to 450 South. At 450 South they should travel East on the North side of the road until they reach 800 West. At that point, they should turn and go South until they reach 500 South. At that point they will cross with the Crossing Guard going East on the North side of the road until they reach the intersection of 600 West and 500 South. At that point, they will cross with the Crossing Guard until they reach the school.

Students who live in the Majestic Meadows housing complex division and students living between 200 South and 450 South, along the west side of 800 West will funnel East to 800 West and travel South on the West side of the road until they reach 450 South-they will then cross the intersection to the South side and continue to 500 South. At that point they will cross with the Crossing Guard going East on the North side of the road until they reach the intersection of 600 West and 500 South. They will then cross with the Crossing Guard until they reach the school.

Zone #5: Students who live between 400 South and 500 South and between 600 and 700 West will funnel South to 500 South and then travel East to 600 West and Cross with the Crossing Guard until they reach the school.

Students who live between 200 and 400 South and 600 and 800 West should funnel East to 600 West. At 600 West they should travel South on the West side of the road until they reach 500 South where they will cross with the Crossing Guard and enter the school.

Zone #6: Students who live between 200 and 300 South and between 500 West and Highway 198 should funnel to 300 South, then continue walking West along the South side of 300 South to 500 West. Then travel South on 500 West to 500 South and cross with the crossing guard and continue West and enter the school.

Zone #7: Students who live between 300 South and 400 South and 500 West and Highway 198 should funnel to 400 South. Then they will travel West to 500 West. Then travel South on 500 West to 400 South and cross with the crossing guard and continue West and enter the school.

Zone #8: Students who live between 400 S and 500 South and between 600 West and Highway 198 should funnel South to 500 South. At 500 South they should turn and go

West on the South side of the road until they reach the Crossing Guard at 500 South and 600 West. They will cross with the Crossing Guard and enter the school.

Zone #9: Students who live between 1100 South and 1400 South and between Highway 198 and 930 West will funnel North to 1100 South. At the intersection of 1100 South and 730 West they will travel North on the East side until they reach 800 South. At 800 South and 700 West they will cross State Road 178 with the Crossing Guard. They will continue to travel North on 700 West on the East side of the road until they reach 500 South. At 500 South they will turn and go East until they reach the intersection of 600 West and 500 South at which point they will cross with the Crossing Guard and enter the school.

Zone #10: Students who live between 930 West(county 3970 W) and 1400 West(county 4400 W) and 1100 South and 1400 South (including students living in the Turf Farm area south of Walmart) will funnel to 930 West and travel North until they reach 1100 South. At 1100 South they will turn and go East until they reach 730 West. At 730 West they will turn and go North until they reach 800 South. At 800 South they will turn and go East until they reach 700 West. At which point, they will cross State Road 178 with the Crossing Guard. They will continue North on the East side of the road until they reach 500 South. At 500 South they will turn and go East until they reach the intersection of 600 West and 500 South at which point they will cross with the Crossing Guard and enter the school.

Zone #11: Students who live between 800 and 1130 South and in a cul-de-sac area East of Turf Farm Road will funnel to 1100 South(county 11200 South). At 1100 South they will turn and go East until they reach 730 West. At 730 West they will turn and go North traveling on the West side of the road to 800 South. At 800 South they will turn and go East to 700 West where they will cross State Road 178 with the Crossing Guard. They will continue North on the East side of the road until they reach 500

South. At 500 South they will turn and go East until they reach 600 West at which point they will cross with the Crossing Guard and enter the school.


Zone #12: Students who live between 730 West and 1040 West and 800 South and 1100 South will funnel North to 800 South. At 800 South they will then travel East to 700 West and cross State Road 178 with the Crossing Guard. They will continue to travel North on 700 West on the East side of the road until they reach 500 South. At 500 South they will cross to the North and go East until they reach 600 West where they will cross with the Crossing Guard and enter the school.


Zone #13: Students who live between 800 South and 1100 South and between 600 and 730 West will funnel North to 800 South and 700 West. They will then cross State Road 178 with the Crossing Guard and travel North on 700 West on the East side of the road until they reach the North side of 500 South. At which point they will turn and go East on the North side of the road until they reach 600 West where they will cross with the Crossing Guard and enter the school.

Zone #14: Students who live between 800 South and 1100 South and between 500 and 600 West (this area is adjacent to Highway 198) will funnel East to 500 West. At which point they will turn and go North on 500 West traveling on the West side of the road until they reach 800 South. At 800 South they will turn and go West to 700 West traveling on the South side of the road. They will then cross State Road 178 with the Crossing Guard. They will continue traveling North on the East side of the road until they reach the North side of 500 South. At which point they will travel East on the North side of the road until they reach 600 West where they will cross with the Crossing Guard and enter the school.
